### Acoma Tribal Member Hunting Proclamation

#### GENERAL INFORMATION-PLEASE READ

---

All game, fish, and other wildlife are protected on the Pueblo of Acoma and may not be taken, possessed or transported unless specifically permitted by Tribal regulations. The Pueblo of Acoma has jurisdiction over fishing, hunting and trapping activities within its jurisdictional boundaries. The authority for licensing such activities resides exclusively in the Pueblo of Acoma (Title 7 Game and Wildlife Code, 2003). This proclamation has been approved by Tribal Council Resolution 2025-005. Therefore, all season dates and regulations found within shall be enforced by The Pueblo of Acoma Law Enforcement Services Department.

The general regulations pertain to all big game hunting on Pueblo of Acoma lands. The regulations found within the proclamation are not all inclusive. **Read the proclamation carefully before hunting or applying for any big game hunting permits.**

The Pueblo of Acoma will issue hunting permits on an application and random drawing basis for Elk, Mule Deer, Pronghorn, and Turkey; Bear, Mountain Lion and Furbearer permits will be issued on a first come, first serve basis. Hunters must complete an application for **each** hunt they desire. Submit applications to the Acoma Game and Fish Enterprise office no later than **4 PM, May 30, 2025.** The drawing will be conducted by the Governor or his designee. This system ensures fairness and consistency in the draw. **The license year of this proclamation will begin April 1, 2025 and will end March 31, 2026.**

## 2025-2026 NEW ITEMS

---

- 1. Hunter Education Incentive Cow Elk Permits:** any registered Acoma Tribal Member youth (18 years and younger on November 14, 2025) that passes an accredited Hunter Education course from **January 1 -November 14, 2025**, will receive a reservation wide cow elk permit valid November 15-23, 2025 free of charge. Proof of Hunter Education certificate and date of issuance must be provided to the Acoma Game and Fish Department to qualify.
- 2. Pick Martin Muzzleloader Deer Permits:** starting in 2025, two (2) muzzleloader only mature buck mule deer permits will be available for the Pick Martin Ranch (Unit 7). **See pg. 24** for more information.
- 3. Extended Season Elk Hunts:** extended season elk hunts will be available in an attempt to assist farmers in the villages by reducing the elk population in this area of Acoma. Extended season dates will be from July 15 – September 26, 2025, for those individuals holding any Unit 1 Horace Mesa elk permit and October 7 – December 31, 2025, for any individual holding an unfilled Unit 1 Horace Mesa elk permit as well as any individual that was unsuccessful on any Tribal Trust Land archery permit. As part of Unit 3 Sandstone Mesa, individuals holding a unit 3 tag may hunt the extended season unit during their licensed hunt dates.
- 4. Villages Unit:** Unit 3a and 3b will be designated as an extended season elk zone. Within these units there will be archery/muzzleloader only zones as well as any weapon zones. Please reference the map on pg. 39; it is the hunter’s responsibility to know where they are and what zone they are hunting.
- 5. Background Checks:** All Tribal and Trophy hunters may undergo background checks prior to the annual Tribal Hunt draw to ensure that they are eligible to obtain a Pueblo of Acoma Hunting License. Background checks will be conducted by the Acoma Department of Public Safety and records of any firearm restrictions will be kept. It is unlawful for felons or domestic violence offenders to possess a firearm in all states in the US. Any applicant that is a felon or domestic violence offender shall be restricted to the use of “Archery equipment ONLY” if successful in drawing an “any legal weapon”, “muzzleloader”, or “shotgun” type license. Those individuals that have felonies or domestic violence convictions or who have pled guilty to such charges will be responsible for ensuring that they follow the firearm restrictions placed upon them. It is the responsibility of individuals with firearm restrictions to notify Acoma Game and Fish Enterprise.
- 6. Pronghorn Management Units:** For management purposes, five (5) Pronghorn Management Units (PMU) have been developed. The units are as follows: PMU 1 all Reservation Lands north of Red Lake not including Berry Hill, Gottlieb, Horace Mesa, La Ventana, or Sanchez Ranches. PMU 2 Red Lake Ranch. PMU 3 Pick Martin Ranch. PMU 4 Bar 15 Ranch. PMU 5 Berryhill, Gottlieb, Horace Mesa, La Ventana, Sanchez Ranch.
- 7. Archery Pronghorn Hunts:** to continue to improve the management quality of the pronghorn herd, the Pueblo of Acoma will be taking a proactive approach to ensuring the quality of the herd and success rates in future years by continuing a limited number of available licenses for the 2025-2026 hunt season. A total of five (5) Mature Buck (MB)

archery permits will be available valid in PMU 1 and PMU 2 ONLY. See Pg. 20 for further information. Due to the high demand for pronghorn tags, a one-year mandatory waiting period will be required after holding a tag. For example, an individual who drew a pronghorn tag in 2024 will not be eligible to hold a tag until 2026.

## IMPORTANT CONTINUING ACTIONS

---

- 1. Designated Hunter:** an enrolled Tribal Member who is authorized by AGF to harvest game for another tribal member (see regulations below). A designated hunter form approved by AGF is required and must be carried by the designated hunter while in the field. AGF may also harvest cow elk for tribal senior, elderly or mobility impaired hunters upon request.
  - a. Elderly Deer: designated hunters may harvest a bag limit restricted mule deer buck for an elderly or Tribal senior license holder who requests this service. The designated hunter must be an immediate family member of the elder or senior. All deer harvested by designated hunters shall be a 3x3 or smaller buck (excluding brow-tines)
  - b. Cow elk: designated hunters may harvest an antlerless elk and deliver meat to any elderly, senior, or mobility impaired tribal member who requests this service. The designated hunter must be an immediate family member of the requesting tribal member.
- 2. Elk Hunts:** The tags allocated for Horace Mesa have been redistributed to allow for muzzleloader and rifle tags. During the archery hunt a total of four (4) tags will be offered instead of eight (8). The remaining four (4) tags will be allocated as two (2) either sex muzzleloader tags and two (2) mature bull only rifle tags.
- 3. Tribal Senior Tag Designation:** Any hunter 70 years old or older at the time of the application deadline (May 30, 2025) will be considered a Tribal Senior. Deer, Elk, and Turkey permits held by Tribal Senior will be free of charge.
- 4. Furbearer Season:** to allow for the harvest of fox and bobcats while predator calling, AGF has implemented a new furbearer season November 20, 2025 – March 20, 2026. A \$20 permit will be required; there will be no bag limit on fox or bobcat. It is a federal requirement for all bobcats harvested on Acoma Lands to be pelt tagged by Acoma Game and Fish Staff. **See Page 24**
- 5. Big Horn Sheep:** Big horn sheep will be considered a protected species on Pueblo of Acoma Lands. Big horn sheep may not be shot at, harassed, or harvested without an official permit issued by the Acoma Game and Fish Department. **No permits will be issued at this time.**
- 6. Mandatory Waiting Period on Deer and Pronghorn Hunts:** Due to the high demand for mule deer and pronghorn tags, a one-year mandatory waiting period will be required after holding a deer or pronghorn tag. For example, an individual who drew a deer tag in 2024 will not be eligible to hold a deer tag until 2026. **Individuals who held a 2024 permit MAY NOT hold a 2025 license.**

- 7. Unit Name Changes:** The names of unit 5 and 6 have been changed to reduce confusion of hunt boundaries. From this point forward Unit 5 will be known as **North Red Lake** and Unit 6 will be known as **Miguel Chavez**. See pg. 31 and 32 for descriptions and maps.
- 8. Spring Turkey Hunts:** a limited number of spring turkey hunts will be issued for the 2025-2026 license year. Spring turkey hunts will be issued by a random drawing. Season dates: April 1 – May 10, 2025, for youth, elderly, and military; April 15 – May 10, 2025 for the general season. Bag limit: one (1) turkey with a visible beard. Legal Method of take: shotguns (20 gauge or larger) and archery equipment only. **No rimfire, centerfire, or muzzleloading rifle may be used to harvest or attempt to harvest a turkey.**
- 9. Governor’s Deer Tag: One (1) Once-in-a-lifetime mule deer permit** will be issued by random drawing. Any enrolled Acoma Tribal Member may apply. The successful applicant will not be eligible for other deer licenses in 2025. Season dates: September 1 - December 31, 2025; Bag Limit: 1 Mature Buck; Hunt Area: Reservation Wide (Excluding non-tribal lands in Bar 15 and Berry Hill; as well as all of the Gottlieb and La Ventana Ranches); Weapon: Any legal weapon.
- 10. Governor’s Elk Tag: One (1) Once-in-a-lifetime elk permit** will be issued by random drawing. Any enrolled Acoma Tribal Member may apply. The successful applicant will not be eligible for other elk licenses in 2025. Season dates: August 15 – December 31, 2025; Bag Limit: 1 Mature Bull; Hunt Area: Reservation Wide (Excluding non-tribal lands in Bar 15 and Berry Hill; as well as all of the Gottlieb and La Ventana Ranches); Weapon: Any legal weapon.
- 11. Acoma Youth Hunt:** Acoma Big Game Hunts will host **one (1)** Tribal Member youth hunter (and guest) at big game camp for a guided cow elk hunt. This will be an all-inclusive hunt with lodging, food, field dressing, and guide included. **See page 18.**
- 12. Javelina Permit Required:** A **\$10.00** javelina permit is now required for tribal members. In attempt to better manage a native species, AGF will issue an unlimited number of javelina permits. All successful hunters are required to present harvested javelina to AGF for data collection. **See Page 28**
- 13. Hunters may hold multiple elk permits:** In attempt to increase hunter opportunity, hunters may hold multiple elk tags during the 2025-2026 license year. Hunters may hold: one (1) archery tag, (1) muzzleloader **or** rifle tag, and one (1) leftover cow elk **or** population management hunt. Youth, elderly, senior, active/veteran military may hold (1) cow elk tag **and** (1) population management hunt.
- 14. Dogs may be used for the Mountain Lion Bounty from April 1 – August 27 and October 11– December 31, 2025 only.** Dogs **MAY NOT** be used to pursue mountain lions or bears during any open tribal or trophy elk or deer hunting season. Dogs **MAY NOT** be exercised on Acoma Lands without a valid mountain lion or bear permit.

---

## 2025-2026 CONTINUING ACTIONS

---

1. **By Tribal Council Resolution:** only the Acoma Game and Fish (AGF) Department may issue hunting permits for Pronghorn Antelope, Elk, Deer, Big Horn Sheep, Exotic Species, Mountain Lion, Bear, Turkey, Trapping, Furbearers, and Big Game Hunts.
2. **Application Process:** application fee continues to be \$7.00 per application and \$10.00 per application if population management hunt is selected. Hunters may select any three (3) hunts they desire to be drawn for, only one application per tribal member please.
3. **Population Management Hunts:** hunts will be available on an as needed basis on April 1, 2025. Hunters will be added to the list on a first come first serve basis at the Acoma Game and Fish Office. A \$3.00 fee will be assessed to be placed on the list. One population management permit will be issued to each Tribal Member.
4. **Fines-** Failure to complete your hunt survey will result in a \$100.00 fine. Fine must be paid before any future hunting opportunities.
5. **Cash incentives will be given to coyote and mountain lion hunters. See bounty hunts pages for details.**
6. **Mandatory reporting of hunting outcome-**hunters who hunt big game on the reservation are required to report the outcome of their hunt. **Incentives will be given to hunters who bring in harvested game animals for data collection.** A \$20.00 cash rebate will be refunded to tribal member hunters who return their hunt survey on or before the deadline date. Successful hunters who return their hunt survey and provide the animal for data collection will receive a \$30.00 cash rebate.
7. **Surveys must be completed and returned at the end of hunt.** Surveys not returned for the 2025-2026 hunt year will render the hunter ineligible to apply and purchase licenses until survey has been submitted and fine has been paid in full.
8. **Gottlieb and La Ventana Ranches are CLOSED to deer and pronghorn hunting.** In addition, Unit 13 permits issued by New Mexico Game and Fish will not be considered valid hunting licenses for Gottlieb and La Ventana.
9. **Special Hunt Requests-**Acoma Tribal Council has reserved ten (10) permits specifically for other tribes or organizations who at times may request assistance by the Pueblo of Acoma. The Acoma Tribal Administration will determine the hunt dates. Only Acoma Game and Fish or Acoma Rangers staff will be permitted to harvest cow elk outside of Acoma Valley during special hunts. Bull elk, mule deer, or pronghorn do not qualify for special hunt permits outside of Acoma Valley.
10. **Shed Hunting-** Acoma Game and Fish requests that any shed deer or elk antlers be brought to the Acoma Game and Fish Office for scoring. Sheds will be returned to the individual. See page 11 for details.
11. **Archery hunters will be required to qualify for archery hunts; hunts include elk, deer, pronghorn, bear, mountain lion and turkey.**
  - Drawn hunters must qualify for hunts prior to payment of licenses.



- Tribal members can call to schedule a date and time to qualify at their convenience provided a staff member is available to witness qualification
- Qualification is good for three years.
- Qualification rules:
  - a) Must be able to shoot 3 out of 5 arrows into the designated area of target at a distance of 30 yards;
  - b) All hunters will be given four chances per day. Qualification times will be scheduled with Acoma Game and Fish Staff to ensure the safety of all Tribal Members.

**12. Permits will not be mailed to hunters.** In order to ensure that each hunter receives his/her permits. Permits must be picked up at the Acoma Game and Fish Office during regular business hours. Hunters or a responsible party may sign for permits.

**13. Mandatory reporting of wounded animals-**all hunters must immediately report wounded animals to the Acoma Game and Fish Office or Acoma Rangers. Additionally, hunters are encouraged to look for the wounded game for the remainder of their hunt.

**14. Hunting in Acoma Valley-Acoma Valley remains closed** to all scheduled hunting and trapping activities for cultural and religious concerns unless the Head Field Chief provides written permission for a special hunt or hunts. Acoma Tribal Members desiring to hunt the Acoma Valley must obtain written permission from the Head Field Chief. **Proof of written documentation must be submitted to the Acoma Game and Fish Office for an official permit to be issued. Hunter must inform AGF upon completion of success of hunt by survey.**

**15. AGF will be continually updating hunters' mailing addresses, phone numbers, emails and census:**

- Please provide the most updated information on your hunting application.
- All tribal members' census numbers are required on each application.
- Please present your tribal identification card for verification; tribal identification cards may be obtained at the Acoma Census Office.
- Incomplete applications will not be considered.

**16. Title 7 Game & Wildlife Code Exceptions:**

- ✓ Use of hunting dogs allowed for Bear and Mountain Lion Hunts.
- ✓ Beavers may be trapped year-round by contract trapper or Game and Fish Staff
- ✓ Snares, electronic calls, and flagging may be used by contract trapper
- ✓ Tribal Members and Trophy Hunters may legally hold more than one (1) elk license in a hunting year

## GENERAL HUNTING REGULATIONS

---

1. The Pueblo of Acoma reserves the right to refuse the sale or issuance of hunting/trespass permits to anyone.
2. All hunters shall obey all Tribal, State and Federal rules and regulations.
3. All hunters under the age of 18 must have successfully completed a Hunters Safety Program in order to hunt big game. Proof of hunter education certification (CIN #) must be in your possession while hunting or provided to Acoma Big Game Hunts prior to arrival. Hunters born on or before December 31, 1959, are exempt from the hunter education requirement.
4. All hunters who have successfully completed a Hunter's Safety Program are eligible to apply for hunt draw's and purchase a hunt license.
5. **There will be no extensions to any hunts or sale of additional permits.**
6. For all hunts - only the person issued the permit is allowed to hunt. Designated hunter is the only exception see pg. 14
7. Hunters must tag all big game animals immediately after harvest.
8. All big game hunters must detach and fill out their big game tag immediately upon harvesting an animal. The tag must be securely attached to the carcass prior to transportation.
9. The antlers (or the scalp and both ears of female animals) must remain attached to the skull and accompany the carcass to the place of storage or where it will be consumed.
10. All edible portions of game harvested must be transported to a place for human consumption, or provisions must be made to provide for human consumption.
11. Successful harvests must be reported to the Acoma Game and Fish Office, in addition wounded game must be reported to either the Acoma Game and Fish Office and the Acoma Ranger Department.
12. Legal shooting time is during daylight hours. In general, if you can see well enough to shoot safely, you are legal.  
**Taking wild animals or birds by moonlight or artificial light is illegal.**
13. Hunter orange is recommended but not required for rifle hunters.
14. It is the hunter's responsibility to know the unit boundaries and where he/she is permitted to hunt.
15. All motor vehicles including ATV's will be restricted to travel on main roads. The only time you may take a vehicle off a main road is to retrieve legally taken and tagged big game carcasses. All motor vehicles must be licensed and insured.
16. During all big game hunting seasons, non-tribal members may not accompany tribal members in the field unless a trespass permit is obtained from the Acoma Land Office.
17. Acoma Game and Fish employees may remove predatory, nuisance, or injured animals as part of their daily job duties. A report of all such removals will be provided to Tribal Council at the annual program update presentation.
18. **All applicants may be subject to a background check. It is unlawful for felons or domestic violence offenders to possess a firearm in all states in the US. Any applicant that is a felon or domestic violence offender shall be restricted to the use of "Archery equipment ONLY" if successful in drawing an "any legal weapon", "muzzleloader", or "shotgun" type license.**

### IT IS UNLAWFUL:

---

- To take or attempt to take any game in any unit that is not included on the issued permit
- To take or attempt to take any game for another person or to use a permit issued to another person.
- To shoot at, pursue, harass, or drive any game by use of or from a motor driven vehicle or aircraft.
- To shoot at game on, from or across any graded or maintained road.
- To bring unlicensed non-Acoma person(s) onto the reservation without a trespass permit.
- To possess a firearm in or on any motor vehicle with live ammunition in the chamber.
- To possess any alcoholic beverages or illegal drugs.
- To litter on Acoma lands.

- To take or attempt to take any wildlife with the aid of any artificial light.
- To possess or transport big game or parts thereof without a proper carcass tag attached.

**Tribal Members found in violation of Acoma law will be tried in Acoma Tribal Courts. The Pueblo of Acoma reserves the right to accept or deny any or all application(s).**

#### ILLEGAL HUNTING ACTIVITY – IT IS THE HUNTER’S RESPONSIBILITY TO KNOW THE RULES AND LAWS FOUND IN THIS DOCUMENT AND TITLE 7 OF THE POA LAW AND ORDER CODE

**Please remember to read your hunting proclamation. Protect yourself by being aware of what is legal and what is not. In the event of any violations of the Acoma Hunting Proclamation and the Pueblo of Acoma Law and Order Code, you could face the following:**

- Up to 3 years hunting revocation.
- Forfeiture of Equipment – Upon Conviction, any equipment used to violate big-game regulation or laws may be forfeited to the Pueblo of Acoma.
- Pay fines and/or jail time.

#### LEGAL WEAPON:

**Only the following weapons and ammunitions shall be permitted:**

- Only those firearms that allow emission of a full report of explosion. Suppressors may be used by those individuals that have completed the BATFE Background Check and Form 4 process.
- Centerfire rifles only. No fully automatic firearms may be used.
- Semi-automatic firearms with a capacity of no more than five shells.
- Only soft-nosed or hollow point bullets may be used. Fully jacketed or steel jacketed bullets are illegal. Shotgun slugs are illegal.
- Bow and arrow with 50 lb. minimum draw weight. Broad heads with sharp metal blades, with a cutting diameter of 7/8 inch or larger.
- Crossbows will only be allowed for use by mobility impaired hunters, restrictions apply see below for more details.

#### MINIMUM CALIBER/WEIGHT REQUIREMENTS

- Centerfire Rifle: Mule Deer, Cow Elk, Bear, and Mountain Lion - .243 caliber
- Centerfire Rifle: Bull Elk - .264 caliber
- Archery: Elk, Mule Deer, Bear, Turkey, Mountain Lion - 50 lb. min. draw weight
- Muzzleloader: Elk, Mule Deer, Bear, and Mountain Lion - .45 caliber
- Shotgun: Turkey - 20 Gauge

#### CROSSBOWS

Crossbow use is legal during archery and any legal weapon hunts by a certified mobility-impaired hunter only. Bolts must have broadheads with steel cutting edges. No drugs may be used on bolts. Bolts cannot be driven by explosives.

## TRESPASS PERMITS

---

Acoma Natural Resources Land Office is responsible for the issuance of trespass permits for non-tribal members who accompany a licensed tribal hunter. Trespass permits will be valid only for the time period outlined on the hunting permit. It is the hunter's responsibility to ensure that all guests have a Pueblo of Acoma trespass permit with them at all times.

## NON-NATIVE GAME

---

Non-Native game refers to animals that are not native to Acoma Pueblo. These animals include: Feral hogs, Barbary sheep and Himalayan Tahr. These animals may be taken **on Tribal Trust Lands** without a permit; however, the harvest must be immediately reported to the Acoma Game and Fish Office.

## PROTECTED GAME

---

Almost all birds and animals are protected either through Tribal, State, Federal, or international laws. This hunting proclamation generally refers only to animals that are hunted. Many other animals are not included in this proclamation. This should in no way be interpreted to mean that animals not listed here are not protected. For a full list of protected species refer to Title 7 Game and Wildlife Code, 2003, The Migratory Bird Treaty Act, and other Federal Documents. It is the hunter's responsibility to know what animals are protected.

# POACHING-\$1,000.00 CASH REWARD!

---

## **POACHING IS A CRIME. IF YOU SEE A HUNTING VIOLATION, REPORT IT.**

Your information will be kept confidential, and you will be eligible for a cash reward if your information leads to a citation.

If you suspect someone is poaching, try and gather the following information:

1. How many suspects?
2. What do they look like? Do you know them? (Physical Description) height, weight, hair color, clothing, etc.
3. Vehicle Information:
  - a. Type of Vehicle (Truck, Car, ATV, etc.)
  - b. Make and model
  - c. Body Style
  - d. Color
  - e. License Plate Information
4. Date and Time poaching might have occurred
5. Exact Location where poaching might have occurred
6. Photos if possible (cell phone pictures are acceptable)

ADDITIONALLY, do not attempt to poach! You will be caught; if you are caught and convicted you could face jail time, fines, forfeit and seizure of your firearms and be banned from future hunting opportunities.

**Call Acoma Law Enforcement at 505-552-6601 as soon as possible if you witness a violation. The sooner you call to report an incident the better. Use caution when attempting to collect information.**

## MANDATORY REPORTING OF HUNT OUTCOME

---

Mandatory reporting of all hunting is required for all hunters regardless of hunt success. Hunters must complete a hunt survey questionnaire and return the completed form to Acoma Game and Fish Office no later than **January 30, 2026**. Hunt surveys and data not collected from hunters will result in a \$100.00 fine which must be paid before any future hunting opportunities. Surveys can be mailed, hand delivered, emailed, or faxed.

Each hunter must complete a hunt survey whether you are successful or not. Successful hunters must bring their harvested animal to the Acoma Game and Fish Office Monday-Friday from 8am to 4pm for biological data collection. Photos will be taken at the time of data collection.

Please bring the following: complete head and udder (cows only) Sample testing will be used to determine the following:

For Bulls/Bucks:

- i. Antlers will be scored and photographed.
- ii. Teeth collection to provide accurate age of animal.

For Cows:

- iii. Reproductive status will be determined.
- iv. Teeth collection to provide accurate age of animal.

## REBATES AND BOUNTIES

**Cash incentives will be given to hunters who bring in their game animal(s) for data collection.** A \$20.00 cash incentive will be given to tribal member hunters who return their hunt survey on or before the deadline date. A \$30.00 cash incentive will be given to hunters who return their hunt survey and provide game animal for data collection. Incentives may be picked up the same day the survey is provided.

Tribal seniors will not receive a rebate due to the free of charge cost of their permits. However, hunters must provide animals for data collection and return a hunt survey.

Cash rebates and bounties must be picked up at the Acoma Game and Fish Office. No cash will be mailed.

---

## DISCOUNTS

---

**Veterans and Active Military** tribal members will receive a 20% discount.

**Elderly** tribal members will receive a 20% discount. The recognized age of elderly is over 60 at time of application deadline.

**Youth** tribal members will receive a 20% discount. The recognized age of youth is under 18 at time of application deadline.

**Tribal Senior** will not be charged a fee to possess a license. The recognized age of Tribal Senior is over 70 at time of application deadline.

Acoma Game and Fish Enterprise will offer a 50% discount to tribal member hunters who are mobility impaired or who have severe disabilities and illnesses.\* The discount will be given off the full price of one hunt permit only/per species; Hunters must apply for draw hunts and purchase the license to hunt if drawn. The following conditions will apply:

- Individual must be able to provide proof of disability and be medically cleared to hunt to obtain discount.\*\*
- Mobility-Impaired hunters may shoot from a stationary vehicle that is not on a maintained road.
- License holder (Hunter) must be accompanied by another person to assist in tracking and retrieving game if successful.
- The disability can be permanent or a temporary impairment.
- The option of using a crossbow for archery hunts will be allowed for disabled hunters.
- Sights on crossbows may not magnify targets or project light, bolts must have broadheads with steel cutting edges. No drugs may be used on bolts. Bolts cannot be driven by explosives.

*\*A severe disability includes one or more physical or mental disabilities resulting from amputation, arthritis, autism, blindness, burn injury, cancer, cerebral palsy, cystic fibrosis, mental retardation, muscular dystrophy, musculoskeletal disorders, neurological disorders, paraplegia, quadriplegia and other spinal cord conditions, sickle cell anemia, and end stage renal disease or a combination of permanent disabilities which can cause comparable substantial functional limitations.*

*\*\*Proof of disability or impairment must be given by physician's office and must be on physician's letterhead with physical address and contact number.*

Discounts may not be combined.

---

## DESIGNATED HUNTER

---

An enrolled Tribal Member who is authorized by AGF to harvest game for another tribal member (see regulations below). A designated hunter form approved by AGF is required and must be carried by the designated hunter while in the field. AGF staff may also harvest cow elk for elderly, senior, or mobility impaired hunters upon request.

a. Elderly/Senior Deer: designated hunters may harvest a bag limit restricted mule deer buck for an elderly or senior license holder who requests this service. The designated hunter must be an immediate family member of the licensed hunter. All deer harvested by designated hunters shall be a 3x3 or smaller buck (excluding brow-tines)

b. Cow elk: designated hunters may harvest an antlerless elk and deliver meat to any elderly, senior, or mobility impaired tribal member who requests this service. The designated hunter must be an immediate family member of the requesting tribal member.

---

## APPLICATION INFORMATION

---

Application Process and Fee: a non-refundable application fee of \$7.00 per application per species and \$10.00 per application if population management hunt is selected will be charged for all applications. Hunters may select any three (3) hunts they desire to be drawn for; only one application per tribal member will be accepted.

Applications are available at the following locations: Acoma Game and Fish Office, Acoma Tribal Administration Office, or on our website at [www.acomabiggamehunts.com](http://www.acomabiggamehunts.com).

Application(s) and application fee(s) must be submitted to the Acoma Game and Fish Office no later than **4PM on May 30, 2025**. Applications received/post marked beyond this date will not be considered.

Draws will be June 6, 2025, at Acoma Tribal Administration Office (Council Chambers). The results of the draw will be available the afternoon of June 6, 2025. Draw results will be posted at the Acoma Game and Fish Office, Tribal Administration Office and on both websites. *Draw date and draw result dates are subject to change without notice.*

Successful drawn applicants must submit full payment for each hunt drawn no later than 4PM on July 25, 2025. Permits not paid for after this date will be forfeited and resold to tribal member hunters who were not successful in the draw; permits are first come first serve basis until 4:00 PM on the day before the beginning of the hunt or until sold out, or whichever comes first. Permits will need to be picked up, permits will not be mailed.

Archery hunters will be required to qualify for archery elk, deer, and pronghorn hunts. Drawn hunters must qualify for hunts prior to payment of licenses. Tribal members can call to schedule a date and time to qualify at their convenience provided a staff member is available to witness qualification.

**REFUNDS WILL BE MADE ON A CASE-BY-CASE BASIS PRIOR TO THE OPENING DAY OF THE PERMITTED SEASON. NO REFUNDS WILL BE ISSUED ONCE THE HUNT HAS STARTED. PERMITS MAY NOT BE TRANSFERRED.**

If a permit is lost or destroyed, a **duplicate permit will be reprinted for an administrative fee of \$5.00**. Duplicate permits must be picked up at the Acoma Game and Fish Office.

**You may apply for multiple hunts; you will only be drawn for one hunt.**

**Elk: Tribal Members may hold 1 archery, 1 rifle OR Muzzleloader, and 1 left-over cow elk OR population management tag**

**Deer: Tribal Members may hold one (1) mule deer tag per season (A ONE YEAR MANDATORY WAITING PERIOD WILL APPLY FOR ANY DEER TAG HELD)**

**Pronghorn: Tribal Members may hold one (1) pronghorn tag per season (A ONE YEAR MANDATORY WAITING PERIOD WILL APPLY FOR ANY PRONGHORN TAG HELD)**

## Gottlieb/La Ventana Ranch E-PLUS

Tribal hunters who wish to hunt elk on both the Gottlieb and La Ventana Ranches may now do so under the State of New Mexico Elk – Private Lands Use System (E-PLUS). These licenses are issued as “ranch only” and are valid only on Acoma owned land within these ranches. **Since these ranches are out of the “Core Occupied Elk Range” the permits are valid only on the deeded acreage, not on BLM or State parcels within these ranches.** Authorization certificates will be issued first come, first serve.

The deadline to obtain an authorization certificate from Acoma Game and Fish Enterprise is August 22, 2025. Hunters must submit the authorization certificate and license fee to any New Mexico Game and Fish Office on or before August 29, 2025, for archery elk and September 26, 2025, for muzzleloader elk. A hunter who obtains an authorization certificate may purchase only one private land elk license and may not hold a New Mexico private land and a public draw elk license in the same year.

## POPULATION MANAGEMENT HUNTS

---

Acoma Tribal members who are experiencing crop damage by the resident elk herds should contact the Acoma Game and Fish Office; the need for hunts will be determined by Acoma Game and Fish and Tribal Administration on a case-by-case basis. Individuals attempting to harvest elk without a depredation license will be considered poaching and are subject to prosecution.

- Tribal members who wish to be considered for Population Management hunts may apply to be placed on a call list for the opportunity to harvest problem elk. Only those tribal members who were unsuccessful in the normal elk draw may apply. The first applicant drawn will be placed at the top of the list; all applicants will be drawn and placed on the list in the order in which they are drawn. In the event that a conflict arises between a tribal member and the resident elk herd, Acoma Game and Fish will determine the need for population reduction and contact the next available Population Management hunter. The hunter will be asked to accept or decline the hunt. If the hunter declines, the next hunter on the population management list will be contacted. Bag limits for Population Management Hunts will be primarily cow elk, since these hunts are intended to reduce population in specific areas.
- **Population Management Fees:**

If a hunter is contacted and accepts a Population Management hunt, he/she will be required to pay the Tribal Cow Elk License fee of \$50.00 plus the appropriate taxes. Successful Population Management Hunters will be required to check in their cow elk at the Acoma Game and Fish Office so that biological samples may be collected. These hunts are on a draw basis.

## MENTORED YOUTH HUNT

**Acoma Youth (Under 18 on May 31, 2025) may apply for the mentored youth hunt in addition to the general elk draw. Submit Youth Hunt application to the Acoma Game and Fish Office.**

**APPLICATION PERIOD: April 7, 2025 – May 30, 2025**



Acoma Enrolled Tribal Members or children of enrolled Acoma Tribal Members under the age of 18 on or before May 31, 2025, are eligible to apply for an all-inclusive guided cow elk hunt through Acoma Big Game Hunts. The lucky winner and a parent mentor guest will stay at the Big Game Hunts Camp from Monday, August 25 – Saturday, August 30, 2025 (or until tag is filled). Acoma Big Game Hunts will provide a canvas wall tent, queen bed, meals, shower facilities, guide, field dressing, meat prep, and a rifle for the duration of the hunt if required.

Tribal Member Youth of any skill level and experience who are interested in big game hunting are encouraged to apply. Completion of hunter's education is required prior to the hunt date.

**One (1)** Youth Hunter will be selected for the Mentored Youth Cow Elk Hunt

**To apply:** Visit the Acoma Game and Fish Office and complete the Youth Hunt Application before May 30, 2025.

### **What you will need:**

1. A desire to hunt big game on Acoma
2. Hunter Education Card or Mentored-Youth Hunter Number
3. Copy of Certificate of Indian Blood (CIB) for enrollment verification for youth and/or guardian
4. A 150-word essay describing the importance of wildlife management to you

Winner will be selected on the day of the hunt draw. There is no cost for this hunt, all equipment and food will be provided by Acoma Big Game Hunts

**Pronghorn Management Units:** For management purposes, five (5) Pronghorn Management Units (PMU) have been developed. The units are as follows: PMU 1 all Reservation Lands north of Red Lake not including Berry Hill, Gottlieb, Horace Mesa, La Ventana, or Sanchez Ranches. PMU 2 Red Lake Ranch. PMU 3 Pick Martin Ranch. PMU 4 Bar 15 Ranch. PMU 5 Berryhill, Gottlieb, Horace Mesa, La Ventana, Sanchez Ranch.

**Archery Pronghorn Hunts:** to continue to improve the management quality of the pronghorn herd, the Pueblo of Acoma will be taking a proactive approach to ensuring the quality of the herd and success rates in future years by continuing a limited number of available licenses for the 2025-2026 hunt season. A total of five (5) Mature Buck (MB) archery permits will be available valid in PMU 1 and PMU 2 ONLY.

**Mandatory Waiting Period:** Due to the high demand for pronghorn tags, a one-year mandatory waiting period will be required after holding a tag. For example, an individual who held a pronghorn tag in 2024 will not be eligible to hold a tag until 2026.

## BEAR AND MOUNTAIN LION HUNTS:

Tribal members may hire certified outfitters to assist in the harvest of mountain lions and bears. A certified outfitter is defined as: “A legally licensed outfitter that has presented required documentation to and has registered with the Acoma Game and Fish Department.” It will be the responsibility of the tribal member to pay any fees the outfitter may impose. Additionally, the tribal member is responsible for all actions of the outfitter. Non-Tribal Members who assist with use of dogs will be considered an outfitter even in the event that no fees are charged. Before hunting on Acoma lands all outfitters/guides are required to obtain a trespass permit from the Acoma Land Office.

Outfitters must supply the following information to the Acoma Game and Fish Department:

1. Outfitter Name and Outfitter License Number
2. Completed Waiver
3. Proof of Insurance
4. Copy of current driver’s license
5. Number of dogs to be ran
6. Copy of trespass permit issued by the Acoma Land Office

### Turkey Rules and Regulations

- The bag limit for turkey is one (1) bearded turkey. A bearded turkey is defined as a turkey with a visible beard patch protruding from its chest.
- The beard and a surround patch of feathers must remain on the bird until it is checked in and is delivered to the place it will be stored.
- Spring turkey may only be harvested with a shotgun 20 gauge or bigger, or archery equipment.
- Rimfire and centerfire rifles are not legal methods of take for spring turkey.
- Acoma Game and Fish must be notified immediately if a bird with a leg band or radio transmitter is harvested.
- Youth: **Under 18**; Elderly: **60 or older**; Military: **Veteran or Active**
- Application deadline: **March 15, 2025**
- Turkey Draw: **March 20, 2025**
- Payment Deadline: Youth, Elderly, Military **March 29, 2025**

5. All Bobcats must be presented to Acoma Game and Fish Enterprise no later than **30 days** after harvest for CITES tagging. Only Acoma Game and Fish personnel are authorized to permanently tag Bobcat pelts harvested on Acoma Pueblo lands.
6. Trapping areas will be assigned.
7. Traps must be permanently marked and registered with a trapper ID number.
8. Travel is restricted to established roads only.
9. Trappers must remove all evidence of trapping including trap flags before trapping is complete.
10. Acoma Valley is closed to trapping without permission from Head Field Chief.

7. All teams must have hunting permit in possession at all times.
8. Contest begins Saturday and ends Sunday.
9. Legal firearms: .204 - .25 caliber centerfire rifles, shotguns no smaller than 20 gauge - including semi-automatic weapons.
10. Hunters may use artificial/electronic/handheld calls/decoys; use of live animals or any type of bait is prohibited.
11. Hunters must hunt together at each setup.
12. ATV'S/UTV'S prohibited.
13. Video filming is prohibited.
14. Use of artificial lighting is prohibited.

19. Mountain Lions, Bobcat, and Fox carcasses will remain the property of the Pueblo of Acoma.

Managing javelina as a big game species is an important step in the understanding and establishment of a native species on Acoma. Current population numbers require a permit to harvest the animal and report of harvest to the AGF for biological data collection. Biological data collection will assist AGF in determining the population size, demographics, age structures, and distribution of the species. Listing javelina as a big game species will allow AGF greater opportunities to monitor the populations and assist the expansion of a native species.

Some Tribal Members have expressed concern over the damage that javelina can cause to infrastructure in the backcountry and the challenges that this may present. It is important to understand the difference between feral hogs and javelina. Javelina root for their food and leave evidence of overturned soil; most commonly at the base of trees, shrubs, or cactus. They are not known to cause extensive damage commonly seen with the presence of feral hogs. Feral hogs, not javelina, can cause major damage to back country infrastructure such as roads and water pipelines.

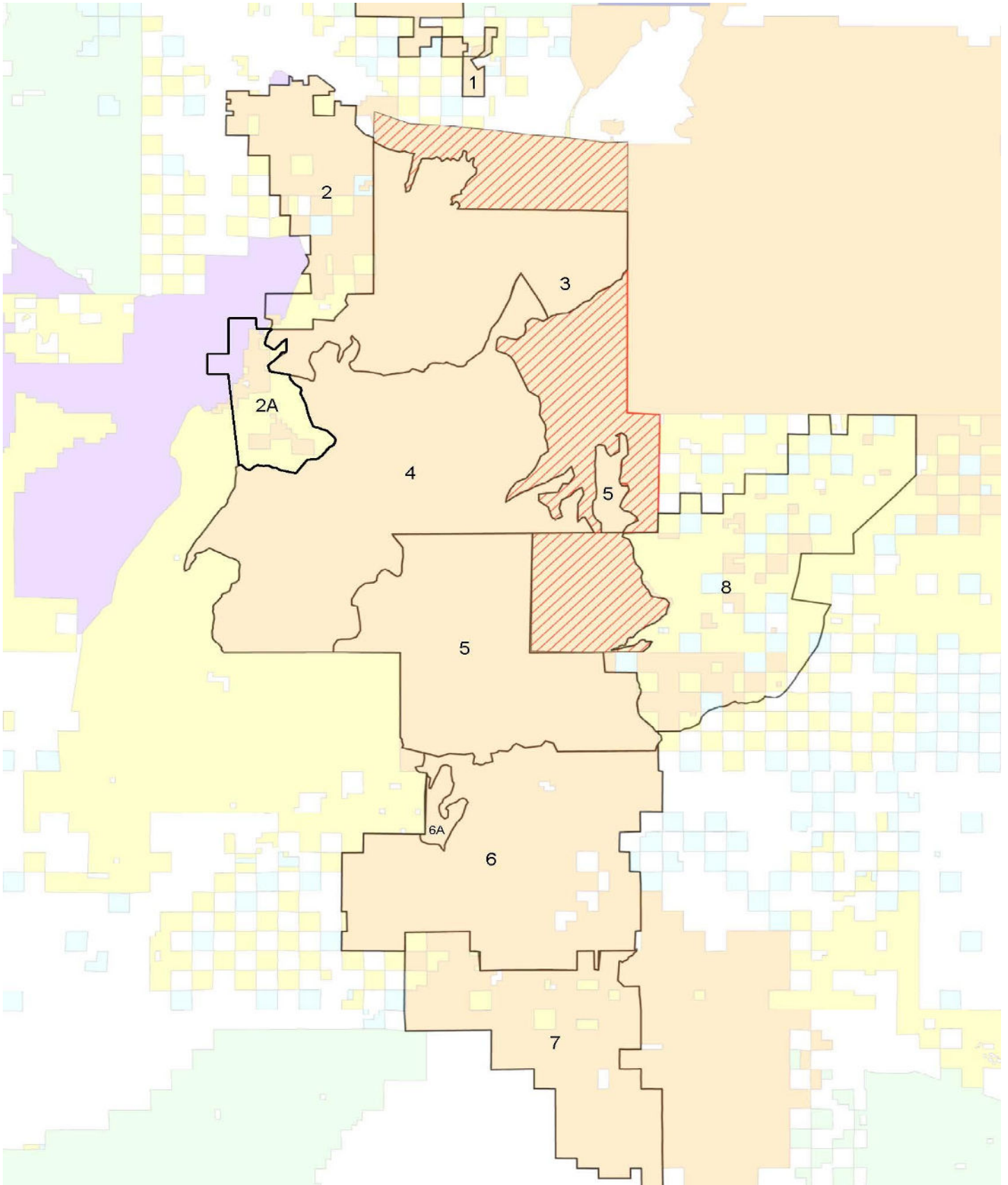

| Unit 3   | Sand Stone Mesa                                       | The southern boundary of the unit proceeds from the western reservation boundary below the top rim of Putney Mesa across the mouth of Largo Canyon ( <b>Unit 3 does not include any part of Largo Canyon</b> ). From the eastern edge of the mouth of Largo canyon the eastern boundary of the unit proceeds northeasterly along AR-292 to the intersection with AR-29. The eastern boundary then follows AR-29 to the Crow Point Intersection with Haak'u Road. From Crow Point the eastern boundary follows Haak'u Road to the edge of the Acoma Valley Unit. From the edge of Acoma Valley the boundary is the edge of the mesa top to the eastern Reservation boundary. The western unit boundary follows the reservation boundary north residential boundary fence. The north boundary proceeds east along the residential boundary fence to the edge of McCarty Mesa. The unit boundary follows the top edge of McCarty Mesa northerly then easterly to the eastern reservation boundary. The western boundary is the western reservation line. |
| Unit 3a  | Woods Mesa  | The southern boundary of the unit proceeds from the eastern reservation boundary along the residential area boundary fence to Mesa Hill Canyon (The large canyon that extends south from Mesa Hill Road). Mesa Hill Canyon defines the western edge of the unit. The western edge proceeds north until the northern edge of Woods Mesa. The northern edge of Woods Mesa defines the northern edge of the unit. The northern edge proceeds east to the intersection of the eastern reservation boundary line.  |
| Unit 3b  | McCarty Mesa  | The southern boundary of the unit proceeds from the eastern reservation boundary along the residential area boundary fence to the western edge of McCarty Mesa ( <b>Anzac is not included in Subunit 3b</b> ). The western edge proceeds north to the northern edge of McCarty Mesa. The northern edge of the unit is defined by the northern rim of McCarty Mesa and proceeds west to the eastern edge of McCarty Mesa. The eastern edge of the unit follows the eastern edge of McCarty Mesa south to the intersection with the residential area boundary fence.  |
| Unit 4   | Brushy Mountain                                       | The southern boundary of the unit follows the reservation line east to the eastern edge of Cebollita Mesa. The edge of Acoma valley is the eastern boundary of the unit. The north boundary of the unit is Haak'u Road to the Crow Point intersection. From this point the north boundary follows AR-29 to AR-292. AR-292 to the western edge of the mouth of Largo Canyon ( <b>Unit 4 includes Largo Canyon</b> ). From the mouth of Largo Canyon the unit boundary is the top rim of Putney Mesa to the western Reservation line. The west boundary is the west Reservation line.   |
| Unit 5   | North Red Lake; includes Majors Pasture and East Mesa | The north boundary of the unit follows the Knoblock pasture fence to the east edge of Cebollita Mesa.
